NOTE: A discussion ensued w/guest Quinton Stewart, a new owner who bought Villa at 24205 Nicklaus Ct. who has moved here from state of WA. He is VERY concerned about whether he will be able to remain in this neighborhood with the information he is now learning about upcoming increased costs in HOA dues, etc. Foremost on his mind was a section of his irrigation system was frozen and needed to be fixed; thought is Environment Turf was responsible

(and

Kimberly was aware of this problem in Feb,'24 and she had talked with Clint (owner) and Quinton was to get with him for possible solution, but did not (when Inspection took place, the system was probably turned on to cause pipe to freeze). Liability is with vendor, which in April was sold to Custom Lawn.

Everharts also attended to learn WHY Special Assessments and certain items in the neighborhood needed to be done immediately.....and remind the Board many retired residents live in this community and were vert concerned about all the upcoming costs.
